

# Maine's Coastal Islands


- 3000 to 4500 coastal islands with diverse management and ownership

- How are island users impacting the islands?




#### **Maine Island Trail Association**

Environmental and Social Monitoring (p. 35)

Program Priorities: Set up a <u>Monitoring Task Force</u> to develop a long term monitoring plan for the public islands.

 Identify the social and environmental indicators for visitor experience and use area conditions;

•define standards for the level of acceptable change;

•determine field research methods to monitor conditions and experiences against established standards;

•enhance existing monitoring programs and data collection techniques to align with new monitoring goals. The Island Monitoring Task Force Goal: To develop recreational use management information and techniques that island owners, managers and volunteers can use to achieve resource and recreation management objectives.
